### **Job Purpose**

- •To undertake holistic family assessments of need and risk assessments, using signs of safety model, where children and families have been impacted by the experience of domestic abuse.
- •To provide packages of intervention which may include direct support to children and their parents/carers and whole families, group work and/or advice and support to professionals in the multiagency network around the family.

### **Principal Accountabilities:**

- To carry out holistic assessments an interventions with children and young people within their family context. This may include work on parent child relationships or group work or family work where appropriate.
- 2. To assist parents/carers in their understanding of the impact of domestic abuse, so that they respond appropriately to the emotional needs of children and young people.
- **3.** To attend and initiate multi agency meetings such as Team around the Family /Child In Need meetings where appropriate.

- **4.** To work jointly and in partnership with other agencies and community organisations to meet the unique assessed needs of families recovering from the impact of domestic abuse.
- **5.** To increase understanding through consultation and training to other professionals in relation to the impact of domestic abuse on children.
- **6.** To work with team to co create and implement effective monitoring and evaluation systems and to assist with the production of reports as required by our funders.
- **7.** To ensure all work is carried out to Family Action minimum standards and is designed and delivered to maximise agreed outcomes.
- **8.** To be responsible for ensuring that children and families receive holistic support that is appropriate to their needs, including sign posting to other services where appropriate.
- **9.** To ensure that all assigned work adheres to Family Actions Safeguarding Policy and ensure LSCB procedures are followed in the event of any child protection issues or concerns.
- 10. To take responsibility for accessing supervision and responding to any case or service decisions effectively, recording all decisions and ensuring that confidentiality and professional boundaries are maintained at all times.
- 11. To comply with Family Action's Health and Safety Policy, Data Protection Policy and to protect the health, safety and welfare of themselves and others.
- **12.** To comply with Family Action's Diversity & Equality Policy and our Ethical Policy in every aspect of your work and positively promote the Principles of these policies amongst colleagues, service users and other members of the community.
